Minutes unanimously approved for October 2022 meeting with a motion carried by Kelley and seconded by Helen.

Public Comment: none as there were no members of the public present

Student Panel: Kaleb Gresham, 12th grade, and Wyatt Braun, 11th grade, shared their thoughts, projects and ideas for school improvement in the future. Both of Kaleb's parents, as well as an aunt, attended the NYC Outdoor School, TRCS' predecessor. Kaleb is working on a documentary film of the history of the school and its' impact on the students as a public charter school. Wyatt is happy to return this year and is deeply engaged in the school.

Re-Accreditation: Jay described the time-consuming intensive process of meeting the requirements to reach the deadline of 2023. He asked for help from the Board and Kelley Moriarty stepped up to commit to the initial request to meet monthly for 4 months with a small committee to move this along. The rest of the Board indicated they may be available for shorter, defined projects as they come up.

2023 Meeting Calendar: The Board moved to approve the calendar as it was presented in the packet with the addition of a scheduled meeting on March 14, 2023 from 4:30-5:30 pm.

Wait list policy follow up discussion: Jay explained the minor editorial changes to the policy in the packet and we agreed Item #2 should be shown first to avoid confusion as to the priority of family members of existing students, which is first.

Review of the TRCS Annual Report will be postponed to the December meeting to give the Board more time to review it.

Principal Report: Jay indicated they are looking to hire another Community Coordinator and hope to have one on board soon. There are 48 students and the staff is doing well.
