The Twin Rivers Advisory Board unanimously approved the following action:

The Twin Rivers Charter School Advisory Board finds that the process used to investigate the incident under appeal followed the proper procedure based on the guidance and resources provided at the time by 4J and ODE Administrative staff.

The Advisory Board further finds that the guidance given by 4J and ODE Administrative staff may or may not have overlooked a potential Title 9 connection in the incident.

The Advisory Board does not agree to rescind the findings as requested in the appeal, dated April 11<sup>th</sup> 2022, but does require an edit to the finding document, dated March 17<sup>th</sup>, 2022, to remove the word “expulsion” from the second to last paragraph of the report.

Further, the Advisory Board directs the Executive Director of Northwest Youth Corps to work with the families of both the claimant and respondent in an attempt to find a mutually agreeable solution to the requests outlined in the respondent’s appeal.
